- 3) APPROVAL OF BILLS PAYABLE REPORT On a motion by Keeffer second by Smith to approve the Bills Payable Report as presented. ALL AYE.
- TREASURER'S REPORT ACCEPTANCE

  Buss explained the Board is approving Fehr Graham to send out bid packets in March for upcoming projects. On a motion by Keeffer second by Smith to approve Street Improvements in the amount of \$88,650. ALL AYE.

# 14) DISCUSS/APPROVE INCREASING CAPITAL IMPROVEMENTS FOR WATER/SEWER

The Board discussed implementing a \$4 increase for storm water and \$25 for sewer to get the Village accounts where they need to be to complete the work necessary to prevent flooding within the Village. The adjustment is to take effect on January's mailed bills for February. On a motion by Rood second by Keeffer to approve increasing for the storm drain fee and capital improvement for sewer.

Buss noted that the Fall Festival went well. The parade was one of the highest entry years at 162 participants. The pavilion is estimated to be done in 3 weeks. Downtown work continues.
